

THE BACKYARD CRUSHER SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN

A PURCHASE WILL NOT INCREASE CHANCES OF WINNING

The Backyard Crusher Sweepstakes (the “Sweepstakes”) is sponsored by the ROYAL DOCKS BREWING CO. (“Royal Docks”) located at 5646 Wales Ave. NW, Massolin, OH 44646 (collectively “Sponsor”).

2. ELIGIBILITY:

The Backyard Crusher Sweepstakes is open only to legal U.S. residents, who are at least 21 years of age or older as of June 18th, 2021. Officers, directors, and employees of Royal Docks are not eligible to win. Immediate family members (spouses, parents, children, and siblings, and their spouses and those living in the same household of such persons (whether or not related thereto) are not eligible to win. By participating, entrants agree to be bound by the Official Rules and the decisions of the Sponsor. All federal, state and local laws and regulations apply. Void wherever prohibited by law and outside the listed country.

3. TO ENTER:

No purchase is necessary, and a purchase does not increase chances of winning. The Sweepstakes begins on June 18th, 2021 at 12:01am Eastern Time (“ET”) and ends on July 12th, 2021 at 11:59pm ET (“Promotion Period”). The time will be determined by the Sponsors’ timekeeping systems. The Sponsor will have the sole discretion in determining the timeliness of any action or inaction related to this Sweepstakes. All times mentioned in these Official Rules are Eastern Time.

During the Promotion Period the Sweepstakes may be entered by:

Visit www.docks.beer/backyard and follow the instructions to complete the registration form and click the Enter/Submit button. All information provided must be truthful, accurate and complete. Upon successful completion and submission of an entry, one entry will be entered into the Sweepstakes.

Or an extra entry will be entered if you post a picture of you enjoying Backyard Crusher on Facebook or Instagram and tag @royaldocksbrewing . No purchase necessary. RDBco. Staff will manually input these entries into the drawings. RDBco. Is not responsible for errors when trying to post about the contest.

Limit one entry per person and per household address. Received entries become the property of Sponsors and will not be returned.

No mechanically reproduced entries of any kind permitted. Illegible and incomplete entries are void. Sponsors are not responsible for lost, late, mutilated, misdirected entries or entries not received. If there

is a dispute over who submitted an entry, the entry will be deemed to have been submitted by the authorized account holder of the email account identified on the entry form. The authorized account holder of an email account is deemed to be the natural person who is assigned to an email address by an Internet access provider, service provider, or online organization responsible for assigning email addresses for the domain associated with the submitted email address.

4. PRIZE:

Two Prize Winners will be selected to receive (1) Backyard Crusher Lawn Chair and Cooler each, including shipping of above prize. Approximate retail value of the prize is \$250.

Prizes consist of only those items specifically listed as part of the prize. Sponsors reserve the right to substitute any prize with a prize of equal or greater value in its sole discretion. Federal, state, and local taxes on prizes, if any, and any other costs, fees and expenses not listed above as specifically included as part of the prize are the sole responsibility of Winner. An IRS Form 1099 and other tax-related forms and documents may be issued by Sponsors if required by law.

Prizes are non-transferable and non-refundable, and no substitutions by Entrants will be permitted.

5. WINNER SELECTION:

Two Winners will be selected by random drawing on or about July 13th, 2021 from all eligible entries received during the Promotion Period. Decisions of the Sponsors are final on all matters. Odds of winning will depend upon the number of eligible entries. No substitution or transfer/assignment of prize by Winners is permitted. Winner must complete the prize paperwork within 3 business days of notification.

6. WINNER NOTIFICATION AND RELEASES:

On or around the drawing date, Sponsors will attempt to notify the potential Winner via email. If a potential Winner: (a) does not respond after the first attempted contact from Sponsors within 48 hours, (b) is not in compliance with these Official Rules, (c) does not meet the eligibility requirements, (d) declines the prize, or (e) does not sign and return required documents or provide required identification by deadlines established by the Sponsors, Winner will be disqualified and the prize awarded to an alternate winner as determined by random draw from the remaining eligible entries. Sponsors will conduct up to two alternate drawings for the prize, time permitting.

The potential prize Winner may be required to provide confirmation that he/she is the owner of the relevant email address. fraud, misconduct or technical failures destroy the integrity of the Sweepstakes; or if a computer virus, bug, wireless failure, or other technical problem corrupts the administration, security, or proper administration of the Sweepstakes as determined by Sponsors, in its sole discretion. If Sponsors

terminate the Sweepstakes, Sponsors will pick the winner(s) in a random drawing from among all eligible, non-suspect entries received as of the termination date and will post notice of its action on Sponsors' website. Sponsors reserve the right to disqualify, freeze or prohibit the participation of an individual if fraud or tampering is suspected, or if the individual fails to comply with any requirement of participation or with any provision in these Official Rules. Sponsors reserve the right to disqualify any individual from further participation in the Sweepstakes if Sponsors conclude, in its sole discretion, that such person: (a) has attempted to tamper with the entry process or other operation of the Sweepstakes; (b) has disregarded or has attempted to circumvent these Official Rules; (c) has committed fraud or attempted to undermine the legitimate operation of the Sweepstakes; or (d) has acted toward Sponsors, any Sponsors' Affiliates, or any other entrant in an unfair, inequitable, annoying, threatening, disrupting or harassing manner. If a dispute arises regarding compliance with these Official Rules, Sponsors may consider, in its sole discretion, data reasonably available to Sponsors through information technology systems in Sponsors' control, but Sponsors will not be obligated to consider any data or other information collected from any other source. Any attempt to undermine the operation of this Sweepstakes may be a violation of criminal and civil laws. Sponsors reserve the right to disqualify and/or seek damages from any individual making any such attempts to the full extent permitted by law. Any failure by Sponsors to enforce any of these Official Rules will not constitute a waiver of such Official Rules. EXCEPT WHERE PROHIBITED, ENTRANTS AGREE THAT ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS SWEEPSTAKES, OR PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY WITHOUT RESORT TO ANY FORM OF CLASS ACTION, AND ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED BY ENTRANT WITH REGARD TO THIS SWEEPSTAKES, BUT IN NO EVENT ATTORNEYS' FEES, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR OTHER DAMAGES. 11. SEVERABILITY:

If any provision(s) of these Official Rules are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.
